Amended Statement of Social Security Number (OF B 121)

Introduction

This document provides procedures for e-filers filing an amendment of a debtor's social security number (SSN).

Required forms

Per <u>LBR 1007-5(b)</u>, to amend a debtor's SSN, the debtor or debtor's attorney must file an amended <u>Official Form B 121 (OF B 121)</u> and an attached certificate of service.

Every section of the OF B 121 must be completed;¹ and the form must be dated and signed by the debtor or, in a joint case, the debtors.

The attached certificate of service must certify that all interested parties have been served a copy of the amended OF B 121, including creditors, the trustee, and the United States trustee. It must be filed with the amended OF B 121 as a single document in PDF format.

Privacy settings & security

The amended OF B 121 will not be available on the docket for public view. Although, as indicated above, the amended OF B 121 including the full, 9-digit SSN must be served on all interested parties, including creditors, the trustee, and the United States trustee, only the last four digits of the number will be available for public view.

The amended form will appear as a docket entry, but only the court and the party that filed the form will be able to view the linked document. Similarly, a notice of electronic filing will be generated and issued upon filing, but parties receiving the notice will be unable to view the associated PDF.

Filing Procedures

Once the OF B 121 and attached certificate of service have been prepared, file the documents electronically as a single PDF via the following steps.²

¹ As indicated on the form, the right-hand column need only be completed for joint debtor cases. For Part 2, if the debtor does not have an SSN or federal individual taxpayer identification number, this must be indicated via the checking of the appropriate boxes.
