SUMMARY OF CHANGES IN 12/1/23 LOCAL BANKRUPTCY RULES

LBR	Summary of Change
1001-1(d)	Updates effective date for rules, limits the language regarding the superseding of general orders to those orders that pertain to local rules, and eliminates the unnecessary delineation of what cases the rules cover.
2002-1(b)	Rules regarding shortened notice period or limited notice moved to LBR 9013-1 and notice of intent template revised to include both court offices rather than a prompt to enter a single office.
2002-1(j)	Clarifies the court's position regarding limited notice under FRBP 2002(h).
2015-1(b)	Clarifies some chapter 11 reporting requirements.
3001-1(c)	Explicitly limits applicability of rule to claims filed by a debtor on behalf of a creditor.
3015-1(b)(8)	Expands requirement that debtors use LBF 1301 and LBF 1302 to pre-confirmation and requires use of LBF 1301 by creditors for motions for approval of loan modification.
3015-2(b)	Clarifies rule.
4004-1(a)	Revises reference to LBF 1378 to reflect changes in the form.
5005-4(a)	Updates the rule to accurately state the title of the procedures document and removes language indicating that the procedures control in the event of any conflict with the rules.
6006-1	New rule requires that a debtor in possession use LBF 765 to file a motion for authority to reject an unexpired lease or executory contract and LBF 765.5 to lodge proposed orders thereon.
7004-1	New rule regarding service of process in an adversary proceeding.
7005-1	Revisions made in conjunction with addition of new rule, LBR 7004-1.
7008-1	Rule removed because it was duplicative of FRBP 7008.
7012-1	Rule removed because it was duplicative of FRBP 7012.
9006-1	New rule regarding requests for continuances of hearings or extensions of time limits.
9009-1(b)	Modifies requirement for trustees to use designated local bankruptcy forms to account for new forms for proposed orders.
9011-1	Rule removed. Content of subsections (a) and (b) moved to other rules (LBR 9019-1 and LBR 9006-1, respectively) and subsection (c) removed entirely.

LBR	Summary of Change
9013-1(a)	Reference in subsection (3) updated in conjunction with addition of new rule, LBR 7004-1 and subsection (7) removed in conjunction with removal of LBR 7008-1 and LBR 7012-1.
9013-1(b)(1)	Changes location in motion of where parties against whom the motion requests specific relief must be included.
9013-1(b)(2)	Notice of motion template revised to include both court offices rather than a prompt to enter a single office.
9013-1(b)(3)	New location for rules regarding requests for shortened notice periods or approval to limit notice.
9013-1(b)(4)	New subsection regarding motions for emergency order consisting of requirements formally located in LBF 125.
9018-1(b)	Adds reference to FRBP 9018.
9019-1(e)	New subsection (2) consists of content moved from LBR 9011-1.
9021-1	Cross-reference removed in conjunction with removal of LBR 9011-1.
