## Enable Print Scaling in Firefox or Google Chrome

To print the complete confirmation text using the Firefox or Chrome browsers, users must enable Print Scaling to use the scale function to reduce the output or reduce the browser window prior to printing. To enable print scaling, do the following.

- 1. Open Firefox or Chrome and go to the page you need to print.
- 2. Press Ctrl + P to open the print preview dialog. The Print preview page looks as follows:
