LBR	Summary of Change
1007-1(a)(1)	Technical correction reflecting combination of schedules E/F.
1014-2	New rule addressing when motions to change venue must be filed.
2002-1(j)	Rule about limited notice after expiration of the proof of claims deadline deleted pending further consideration by the court or Local Rules Committee.
2015-1(b)(2)(A)	Clarifications and emendations regarding the filing of a final account in a chapter 11 case, including the requirement to file either LBF 1195 or a status report no later than 120 days after entry of the confirmation order.
3007-1(a)(2) & (3)	Modified to reflect what the court requires regarding omnibus claim objections; added a cross-reference to local rules regarding certificate of service.
3015-1(b)(1)	Deleted reference to outdated chapter 13 plan form LBF 1300.05.
3015-1(b)(6)(C)	Deleted section regarding preconfirmation adequate protection payments in a plan as unnecessary and renumbered (D).
3016-1(a)	Deleted provision to designate a chapter 11 case for accelerated treatment as unnecessary given small business and subchapter V options.
4003-1	Formerly noted as “[Reserved]”; now deleted.
4004-1(b)	Clarification and expansion on requirements for obtaining a chapter 11 discharge, including reference to new LBF 1191.5 when discharge is sought under 11 U.S.C. § 1192.
5001-1	Formerly noted as “[Reserved]”; now deleted.
5005-2	Formerly noted as “[Reserved]”; now deleted.
5005-3	Formerly noted as “[Reserved]”; now deleted.
5011-1	Retitled and expanded rule on motions for withdrawal of the district court’s referral to the bankruptcy court of a case or proceeding.
5011-2	Modified LBR on motions for abstention to remove requirement for an affidavit of compliance and clarify when the motion must be filed.
5072-1	Formerly noted as “[Reserved]”; now deleted.
6007-1	Revised rule on abandonment to reflect current practice, require use of applicable LBFs, and modify the deadline for objecting to the chapter 7 trustee’s abandonment of the debtor’s residence to no later than seven days before the first date set for the meeting of creditors.

9015-1	Clarified jury trial procedures by updating references to district court local rules.
9021-1	Updated cross-reference to LR for proposed orders or judgments in non-core matters requiring review, determination, and signing by a district judge.
