Motion to Extend or Impose Stay & Notice of Hearing Thereon

Introduction

This document contains filing procedures for e-filing:

- motions to extend or impose a stay per 11 U.S.C. § 362(c),
- motions to impose a stay per 11 U.S.C. § 362(n), and
- the notice of hearing that must be filed with either (Local Bankruptcy Form (LBF) 721.5).

Filing Procedures

Before filing the objection/response, go to the <u>Motion Re Imposing/Extending Sec. 362 Stay</u> page on the court's website.¹ Use the first hearing date on this page that is at least six calendar days after the motion will be filed to complete the hearing date and time sections of the form.
