Introduction

This document contains information and filing procedures for e-filing objections to trustees’ motions to dismiss, motions to convert, and 10-day notices of default.

When & How to File LBF 1366 Notice of Hearing with Objection

Depending on whether a hearing has been set and the content of the trustee’s motion or notice, either file an objection along with a hearing notice on [LBF 1366](#) or file the objection only. To determine which method to use:

- Check the docket to see if a hearing has already been set on the motion or notice of default (if unsure whether a hearing has been set, check with the Courtroom Deputy—also referred to as the Calendar Clerk—before proceeding¹) and
- Examine the motion to see if it directs objecting parties to use LBF 1366 or whether it asks the court to set a hearing.

Then, proceed as follows:

LBF 1366 & objection

First, [click here](#)² for a list of hearing dates with the judge assigned to your case and identify an available hearing date, time, and location (these hearings will usually be held via telephone).

Then, use the information to complete a notice of hearing on [LBF 1366](#) and file it along with your objection via the [E-filing objection if a hearing has not yet been set](#) section below. The objection and LBF 1366 notice should be filed as a single PDF with the LBF 1366 as the first page.

Objection only

If a hearing has already been set on the trustee's motion or 10-day notice of default,³ prepare an objection and file it per the [E-filing objection only](#) section below.

Filing Procedures⁴

E-filing objection and LBF 1366

If appropriate (see the [When & How to File LBF 1366 Notice of Hearing with Objection](#) section above), use the following steps to file a notice of hearing on LBF 1366 along with your objection:

If a hearing has been set on the motion or notice of default or if the motion or notice asks the court to set a hearing (see the [When & How to File LBF 1366 Notice of Hearing with Objection](#) section above), use the following steps to file your objection:

2	Select Answer/Response
3	Select Reference an Existing motion/ application
4	Enter case number in format YY-XXXXX
5	Select the Objection event
6	Select or add ⁸ represented party
7	Select No to answer “Are you objection to the Trustee abandoning the debtors residence/real property as set forth in the Notice of Meeting of Creditors?” question
8	Check the box to refer to existing event
9	Select “motion” from the picklist options (alternatively, use the on-screen instructions to select all categories for a complete list of filings to which to object)
10	Check the box for the trustee’s motion or notice of default
11	Click Browse... to attach the objection in PDF format ⁹
12	Modify docket text with drop-down box as appropriate
13	Review docket text and submit

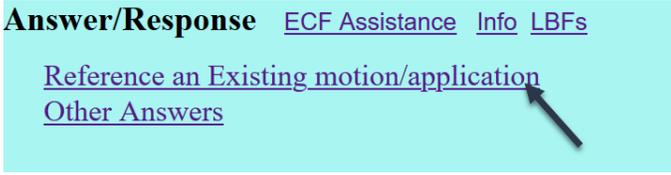
