# Stipulated Continuance of Non-Evidentiary Relief from Stay Hearing

#### Introduction

This document contains filing procedures for using the text-only *Stipulated Continuance of Non-Evidentiary Relief from Stay Hearing* event in CM/ECF.

See <u>Local Bankruptcy Form (LBF) 720.5</u>, *Procedures re: Motions for Relief from Stay*, for more information regarding motions for relief from stay and objections thereto.

### Use of the Event

Use this event only to reschedule non-evidentiary hearings set on objections filed in response to motions for relief from stay that have yet to commence.

The following limitations and requirements apply to the use of this event:

- A stipulated continuance may only be requested for the first hearing set on each motion.
- A new preliminary hearing date no later than 4 weeks from the original hearing must be selected. Hearing dates are available on the court's website.<sup>1</sup>
- The stipulated continuance must be requested no later than one business day before the hearing. Do not use the event the day of the hearing.

#### Waiver of § 362(e) Termination of Stay

The continuance constitutes a waiver by the creditor of the 30-day termination of the stay provided under 11 U.S.C. 362(e) (i.e., the stay will remain in effect).

#### Affirmation of Assent of All Parties to the Motion


