2002-1	Updates to 2002-1(a)(3)(B)(ii), 2002-1(a)(4), 2002-1(a)(6), and 2002-1(b)(1) & (c) to match the new FRBPs.
2002-1(g)(2)	Revisions are stylistic changes including replacement of " <i>pro se</i> " with "self-represented" in conformance with recent changes to the district court rules.
3007-1(b)	Removal of LBR 3007-1(b)(2) eliminates the conferral requirement relating to chapter 11 claim objections.
3019-1	Extends LBR 2002-1(a)(1) to requests for postconfirmation plan modification requests in subchapter V cases confirmed under § 1191(b).
5078-1(a) & (b)	Stylistic revisions.
7001-1(c)(2)	Extends requirement to file an adversary proceeding coversheet to notices of removal and stipulated judgments in lieu of complaint filed on paper.
7004-1(c)	Adds requirement for any party in an adversary proceeding to file a statement regarding the party's service address on new LBF ADV-A the same day the party first files something in the adversary proceeding.
9001-1	Definitions of " <i>pro se</i> " and "SASE" removed in accordance with stylistic changes to LBRs 2002-1(g)(2), 5078-1, 9009-1(a), 9017-1(e), and 9018-1(a).
9004-2(b) & (c)	Updated to conform with numbering changes in Federal Rules of Bankruptcy Procedure.
9009-1(a) & (b)	Stylistic revisions.
9009-1(c)	Revisions allow for additions to forms provided such additions are conspicuous.
