

New Events for the 12/1/2025 Rules & Forms Revisions

This document provides information regarding some of the new and updated events that have been created to go along with the local and national rules and forms changes going into effect on December 1, 2025.

Clerk's entry of default in adversary proceedings

To request the clerk's entry of default per FRBP 7055, new form LBF 7055 must be used and must be filed with the following new event available under the *Motions* and *Notices/Miscellaneous* menus:

Request for Clerk's Entry of Default [Requires LBF 7055 - 12/1/25]

Notice of withdrawal of attorney

An event has been created for filing a notice of withdrawal of attorney when leave of court is not required per new LBR 9010-1(h)(1):

Notice of Withdrawal of Attorney

The event will be available under the *Notices* menu for both bankruptcy main cases and adversary proceedings.

New forms for motions to convert or notice of conversion

The following forms will be required per LBR 1017-1:

Form	Conversion Filing
LBF 348	Notice of conversion from chapters 12 or 13 to chapter 7
	If the case has not previously been converted, a motion to convert from chapter 7 to chapters 11, 12, or 13
LBF 348.1	If the case has previously been converted, a motion to convert from chapter 7 to chapters 11, 12, or 13
